

Pursuant to your request for information relevant to the renewal of liquor licenses, I am providing the following information.

O'Ryan's Irish Pub (I-Pub)

The owner of O'Ryan's Irish Pub continues to work with the police department to mitigate problem behavior at the I-Pub.

Over the last year the I-Pub generated two cases, down from 12 cases the previous year. One of the cases was for a counterfeit \$20 bill and the other was for a disorderly conduct complaint.

I am unaware of any infractions issued by the OLCC to the I-Pub over the last year.

Stop N Shop

While Stop N Shop at 110 Lithia Way continues to be a focal point for open alcohol container violations in the downtown area, I am not recommending to Council that the liquor license approval be denied. The last 12 months has been atypical for the downtown area. As activity downtown returns to normal levels, I would like to continue to check on this location and bring the most recent information to Council as licenses are up for renewal again in 2022.

Citywide violations for open container fell over the year to 41, down from 54 over the previous 12 twelve months.
