Resource Center to better assist transition from custody to resources in hopes to reduce recidivism.	<ul> <li>Housing, Employment, Addiction Services, Mental Health Services, Benefits, Peers, Family Support – All one stop shop</li> </ul>
Monthly Community Meetings	<ul> <li>Education and Discussion</li> <li>CAHOOTs, Community Court, Open lines of communication, Long term work group</li> </ul>
Health Care Reform at the Nation Level for those who are justice involved and pre-trial	<ul> <li>Legislation is moving forward, should improve resources for those who are addicted and suffer from mental health issues</li> </ul>
Local CCO working with the Criminal Justice System to enhance transitional care and MAT	<ul> <li>Committed to finding ways to improve transition from jail to resources</li> </ul>
Medication Assisted Treatment	<ul> <li>Limited to 8 beds due to space and resources (In progress), expandable in new facility</li> </ul>
Concerted effort to use less prison for Drug and Property Crimes	<ul> <li>Community Justice uses prison for minor property crimes far less than other counties</li> </ul>


# Jackson County Part 1 and Part 2 offenses




Medford Police Department Crime Statistics Part 1 and Part 2 offenses

# Proposal for Service District (s)

Create two Resolutions with two Service Districts

One County Wide at .8547 cents per 1000

One excluding the City of Talent at .8719 cents per 1000

Ask the 10/11 cities to pass both resolutions and move the applicable district forward by the BOC
