

BID ADVERTISEMENT

Notice is hereby given that sealed bids will be received by the City of Ashland at its office at 51 Winburn Way or 20 East Main Street (mailing address), Ashland, Oregon, 97520, until 2:00 p.m. on Thursday, June 26, 2014, for the **Taxilane Improvements project at Ashland Municipal Airport - Sumner Parker Field**, at which time bids will be opened publicly and read aloud. Any bids received after the time for opening will not be considered.

Bidders are required to disclose information about certain first-tier subcontractors in a separate envelope as specified in ORS 279C.370. First-tier subcontractor submittals shall be received within two working hours after the date and time of the deadline when bids are due. Bidder must submit a statement in the Bid that the Bidder will comply with ORS 279C.800 through 279C.870 and 40 USC 3141 et seq., as applicable. No Bid for construction will be considered unless the Bidder is properly licensed with the Construction Contractors Board. It is not a requirement that the Contractor be licensed under ORS 468A.720.

The contemplated work to be performed includes construction of new taxilanes and connection to existing taxilanes. Anticipated elements of the improvements include but are not limited to excavation, grading, underground drainage and utilities, pavement section, and asphalt paving.

Drawings, technical provisions, and forms of contract documents may be examined at the City of Ashland, 541-488-5347.

Electronic copies of the Contract Documents and Addendums are posted on the **Oregon Procurement Information Network (ORPIN) website at: <http://orpin.oregon.gov/open.dll/welcome>, Opportunity No. KA1512-1000-14**. The Contract Document and Addendums may be downloaded at no charge, and will not be mailed to prospective bidders. Bidders should consult the ORPIN system regularly until closing to avoid missing any Addenda.

All Bid documents shall be submitted in hard copy. Electronic or e-mailed submissions shall be rejected. It is imperative that those who download the solicitation documents check the ORPIN website regularly for addenda, clarifications, and other notifications that may be pertinent, as well as a Suppliers List of Interested Parties.

To be listed on the Suppliers List, interested parties must be registered on the ORPIN System. Interested Parties can register in the ORPIN system at: <http://orpin.oregon.gov/open.dll/welcome>. Interested parties who download Contract Documents from the ORPIN system will automatically be added to the Suppliers List.

NOTE: OFFERORS WHO OBTAIN CONTRACT DOCUMENTS, SPECIFICATIONS, AND DRAWINGS FROM PLAN CENTERS OR OTHER MEANS WILL NOT APPEAR ON THE REGISTERED SUPPLIERS LIST SHOWN ON ORPIN, UNLESS THEY ADD THEMSELVES TO THE SUPPLIERS LIST IN THE ORPIN SYSTEM.

Contractor prequalification will be per ORS 279 C.430 a minimum of 5 days prior to bid opening.

Each bid shall be accompanied by a cashier's check, certified check, postal money order, or bid bond made payable to the City of Ashland in an amount not less than ten percent (10%) of the amount of the bid. Said check or bid bond shall be given as a guarantee that bidders shall execute such contract as may be awarded in conformity with the bid and contract documents and shall provide surety bond or bonds as specified therein promptly after notification of the award of contract.

Bidders are strongly encouraged to attend a pre-bid meeting for all prime contractors scheduled for 10:00 a.m. on Tuesday, June 17, 2014, at the City of Ashland office at 51 Winburn Way, Ashland, Oregon.

All bidders and primary subcontractors must examine the site and become familiar with all site conditions prior to the bid.

1. The proposed contract is under and subject to Executive Order 11246 of September 24, 1986, and to the Equal Employment Opportunity (EEO) and Federal Labor Provisions.
2. All labor on the project shall be paid no less than the minimum Federal wage rates established by the U.S. Secretary of Labor, and the minimum State wage rates established by the State of Oregon. The Contractor shall pay the rate that is highest of the Oregon State or Federal Wage Rates.
3. Bidders shall supply all the information required by the Project Manual.
4. The EEO requirements, labor provisions, and wage rates are included in the project manual and are available for inspection at the City of Ashland.
5. Bidders shall complete, sign, and furnish with their bids a "Certification of Nonsegregated Facilities" and a statement entitled "Bidder's Statement on Previous Contracts Subject to EEO Clause," as contained in the bid proposal.
6. A contractor or subcontractor who may be awarded a contract of \$10,000 or more will be required to maintain an affirmative action program, the standards for which are contained in the FAA Special Provisions.
7. To be eligible for award, each bidder shall comply with the affirmative action requirements, which are contained in the FAA Special Provisions.
8. Minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin.
9. This contract will be funded in part by a grant from the FAA. In accordance with Federal requirements, the City of Ashland has determined that this contract has subcontracting possibilities and encourages the use of firms owned and controlled by Disadvantaged Business Enterprise (DBE). All bidders are directed to the FAA Special Provisions with regard to the procedures Jackson County will use to achieve these goals.
10. Bidders shall comply with the provisions of ORS 279C.800 through 279C.870 and 40 USC 3141 et seq. Under this project, ORS 468A.720 is not applicable.
11. Bidders shall be properly licensed with the Construction Contractors Board or licensed by the State Landscape Contractors Board.

12. Women will be afforded equal opportunity in all areas of employment. However, the employment of women shall not diminish the standards or requirements for the employment of minorities.
13. Successful bidder shall have current City of Ashland Business License upon bid award.

The City of Ashland reserves the right to reject any and/or all bids and to waive irregularities or informalities in the bid or in the opening.

Bidders shall not withdraw bids after the hour set for the opening thereof, or before award of contract, unless said award is delayed for a period exceeding sixty (60) calendar days.

The award of the contract is subject to approval of the Ashland City Council, the Federal Aviation Administration, and the availability of federal funding.
