## **SUMMARY**

The Climate and Energy Action Plan (CEAP) recommended the creation of a permanent Commission to provide community engagement, input and recommendation making as the plan is implemented and updated over time. These proposed ordinances create a new Climate Policy Advisory Commission and update the purpose, membership, powers and duties and name of the Conservation Commission (Conservation and Climate Outreach Commission) to better align its work to outreach and education efforts associated with the CEAP.

## **POLICIES, PLANS & GOALS SUPPORTED**

- 1) 2019-21 Council Goal #3 – Enhance and improve transparency and communication
- 2) CEAP Year One Implementation Plan – Form and convene a permanent City Advisory Commission

## **PREVIOUS COUNCIL ACTION**

The establishment of a permanent Commission for CEAP was one of the eight initial priority implementation actions outlined in the CEAP that was presented and approved by Council on March 7, 2017. Council elected to create a second CEAP Ad-Hoc on December 5, 2017, rather than a permanent commission.

On February 19, 2019, the CEAP Implementation Ad-Hoc Committee presented its final report and recommendation, which included each of the two proposed ordinances as references. Council accepted all of the recommendations of the Committee and directed staff to place each of the ordinances on a Council agenda for formal deliberation and decision.

## **BACKGROUND AND ADDITIONAL INFORMATION**

The development of the CEAP has benefitted from significant community involvement from its origins in 2015 with the creation of the first CEAP Ad-Hoc Committee (CEAP 1) charged by the Mayor and Council to assist staff, the consultant and the community in the development of the CEAP document. With over 30 total public meetings, including three community wide open houses, the CEAP document was presented to Council for approval in March of 2017.

The Year 1 Implementation Summary recommended an initial focus on establishing the institutional foundation for plan implementation, which included the formation of a permanent City Advisory Commission “to provide guidance and oversight of plan implementation and future plan updates as described in the plan”.

A broad description for this Advisory Commission was included in the CEAP (page 107) and is as follows:

*Oversight – A Citizen Advisory Commission is recommended to oversee implementation of the CEAP. The Commission will be composed of stakeholders who represent Ashland residents, have interest, experience or expertise on climate-relevant topics or related policy work and/or represent key community or civic organizations that may play a role in implementation.*

*Roles of the advisory committee could include:*

- *Monitory and tracking progress towards meeting CEAP goals.*
- *Providing recommendations to the Climate and Energy Coordinator regarding CEAP progress and implementation*

- *Ensuring that the CEAP stays up-to-date over time, with a focus on the three-year plan update cycle*
- *Reviewing and making recommendations as part of the three-year greenhouse gas (GHG) inventory update process*

*It is expected that the Commission will meet at least quarterly, and likely more often in the early stages of implementation*

In December of 2017, Council elected to create a second Ad-Hoc Committee rather than a permanent Commission. The CEAP Implementation Ad-Hoc (CEAP 2) was given a specific scope of work with eight topics to provide recommendations back to the Council. The final topic was “Long term structure and format for citizen advisory role in CEAP implementation”.

CEAP 2 worked with the Conservation Commission to develop a unique structure to ensure that all aspects of CEAP implementation have advisory commission level support and involvement. The Climate Policy Advisory Commission is focused on policy and plan related oversight and recommendations codified in AMC 9.40.040 while the proposed alterations to the Conservation Commission powers and duties provide alignment with community engagement and achievement of overall community action codified in AMC 9.40.020.

Both CEAP 2 and the Conservation Commission unanimously recommend the approval of the two ordinances.

### **FISCAL IMPACTS**

No specific expenditure requests are associated with either ordinance. However, the creation of a new Commission does create additional staff demands. To mitigate that, and to provide continuity between the two Commissions, staff has suggested the possibility of having each Commission meet every other month. This allows a primary staff liaison to staff each Commission and also provides additional time between meetings for smaller, topic based work groups to meet and develop ideas, conduct research and involve others outside of the Commission membership.

Commission meeting dates, times and cadence are not typically included in ordinance language and can be further developed with Council into the future.

### **STAFF RECOMMENDATION**

Staff recommends approval of both ordinances creating the new Climate Policy Advisory Commission and modifying the scope, charge, and name of the Conservation Commission.

### **ACTIONS, OPTIONS & POTENTIAL MOTIONS**

- 1) I move to amend the purpose, membership, powers and duties of the Conservation Commission and re-name the Commission as the Conservation and Climate Outreach Commission with the approval of first reading of Ordinance 3177; and
- 2) I move to create the Climate Policy Advisory Commission with the approval of first reading of Ordinance 3178.

7 **WHEREAS**, the City of Ashland (City) has an interest in promoting climate policy; and

8 **WHEREAS**, the City acknowledges and supports the active involvement and participation of the  
9 community in furthering the goals, objectives and actions contained within the City Council  
10 adopted Climate and Energy Action Plan; and

11 **WHEREAS**, the former Conservation Commission has been instrumental in furthering many  
12 climate and sustainability issues since its inception in 1995

13 **THE PEOPLE OF THE CITY OF ASHLAND DO ORDAIN AS FOLLOWS:**

14 **SECTION 1.** Chapter 2.18 [Conservation Commission], is hereby amended as Conservation  
15 and Climate Outreach Commission to read as follows:

16 **2.18.005– Purpose**

17 **Upon adoption of this ordinance, the Mayor shall establish a permanent Citizen**  
18 **Commission to support the achievement of Ashland’s Community Climate Recovery Goals**  
19 **(AMC 9.40.020) and conservation activities. The Commission shall actively encourage**  
20 **Community entities and individuals to make wise use of resources and make progress**  
21 **toward Ashland’s Community Climate Goals as set forth in the most current City Council-**  
22 **approved version of the Climate and Energy Action Plan.**

23 **2.18.010 – Established Membership**

24 The Commission is established and shall consist of nine (9) voting members including one  
25 representative of the solid waste franchisee for the City; and one representative from Southern  
26 Oregon University; and one representative from the Ashland School District and six (6) other  
27 voting members. At least five (5) of the other members shall reside within the City. ~~The~~  
28 ~~commission shall also consist of certain non-voting ex officio members, including the mayor~~  
29 ~~or one council member serving as council liaison, the Department of Communitiy~~  
30 ~~Development Director and the Electric Utility Director, the Director of Public Works, the~~  
~~Building Official and the City Administrator. The Electric Utility Director shall serve as~~

1 ~~the primary staff Liaison and Secretary of the Commission. The primary staff liaison shall~~  
2 ~~be appointed by the City Administrator and shall serve as Secretary of the Commission.~~  
3 ~~Voting members shall be appointed by the Mayor with confirmation by the City Council.~~

5 **2.18.040 – Powers and Duties Generally**

6 ~~The powers, duties and responsibilities of the commission shall be to educate and advocate~~  
7 ~~for the wise and efficient use of resources by the City of Ashland and all Ashland citizens.~~

8 ~~In doin so the commission shall recommend to the council the adoption of policies,~~  
9 ~~implementation strategies and funding related to:~~

10 ~~A. Recycling, source reduction and solid waste/landfill issues;~~

11 ~~B. Electric conservation issues;~~

12 ~~C. Water conservation issues;~~

13 ~~D. Resource conservation issues;~~

14 ~~E. New power resource decisions, but not including decisions involving~~  
15 ~~wholesale power contracts;~~

16 ~~F. Renewable resource decisions;~~

17 ~~G. Air quality issues;~~

18 ~~H. Education of citizens about efficiency issues ; and~~

19 A. Consistent with City policies and procedures, educate and advocate for Ashland’s  
20 Community Climate Recovery Goals (in accordance with AMC 9.40.020)

21 B. Consistent with the Climate and Energy Action Plan, make recommendations on  
22 strategies, actions, and programs related to the wise and efficient use of resources by all  
23 Ashland citizens, including:

24 a. Consumption of goods and services,

25 b. Materials management, waste prevention, reduction, and recycling,

26 c. Conservation and efficient use of electricity, water, and natural  
27 resources

28 d. Promotion of community, residential, and commercial renewable  
29 resources

30 e. Air quality awareness,

f. Climate resilience and preparedness.

2 **SECTION 2. Codification.** In preparing this ordinance for publication and distribution, the  
3 City Recorder shall not alter the sense, meaning, effect, or substance of the ordinance, but within  
4 such limitations, may:

- 5 (a) Renumber sections and parts of sections of the ordinance;
- 6 (b) Rearrange sections;
- 7 (c) Change reference numbers to agree with renumbered chapters, sections or other parts;
- 8 (d) Delete references to repealed sections;
- 9 (e) Substitute the proper subsection, section, or chapter numbers;
- 10 (f) Change capitalization and spelling for the purpose of uniformity;
- 11 (g) Add headings for purposes of grouping like sections together for ease of reference; and
- 12 (h) Correct manifest clerical, grammatical, or typographical errors.

13 **SECTION 3. Severability.** Each section of this ordinance, and any part thereof, is severable,  
14 and if any part of this ordinance is held invalid by a court of competent jurisdiction, the  
15 remainder of this ordinance shall remain in full force and effect.

2 **AN ORDINANCE CREATING THE CLIMATE POLICY COMMISSION; ADDING**  
3 **NEW AMC CHAPTER 2.27**

7 **WHEREAS**, the City of Ashland (City) has an interest in promoting climate policy; and

8 **WHEREAS**, the City acknowledges and supports the active involvement and participation of the  
9 community in furthering the goals, objectives and actions contained within the City Council  
10 adopted Climate and Energy Action Plan; and

11 **WHEREAS**, the approval of a Climate and Energy Action Plan necessitates an on-going  
12 Advisory body to assist Council in maintaining and updating the plan over time

13 **THE PEOPLE OF THE CITY OF ASHLAND DO ORDAIN AS FOLLOWS:**

14 **SECTION 1.** New Chapter 2.27, Climate Policy Commission, is hereby added to the Ashland  
15 Municipal Code as follows:

16 **2.27.005 Purpose**

17 **The Climate Policy Commission shall support the integrity and focus of the City’s Climate**  
18 **and Energy Action Plan (CEAP). The Climate Policy Commission shall provide climate**  
19 **plan implementation process oversight and recommend updates to the CEAP in pursuit of**  
20 **meeting the climate recovery goals, objectives, and targets set forth in AMC Chapter 9.40.**

21 **2.27.010 Establishment; Membership**

22 **There is hereby established a Climate Policy Commission for the City of Ashland. The**  
23 **Climate Policy Commission shall reflect and represent a wide range of community interests**  
24 **and perspectives. Such interests shall include, but not be limited to, environmental, energy**  
25 **efficiency, renewable energy, academic, business, low income, health, communities of color,**  
26 **and elderly interests. The Climate Policy Commission shall consist of nine (9) voting**  
27 **members. The Climate Policy Commission shall strive to include at least two (2) members**  
28 **who are 35 years old or younger at the time of appointment. Eight (8) of the members shall**  
29 **reside within the City, and one (1) member may be an at-large member living within the**  
30 **City’s urban growth boundary. Either the Mayor or one (1) City Councilor and one (1)**  
**City staff person shall serve on the Commission as non-voting, ex-officio members. The**

1 Commission may optionally include two (2) student members representing the Ashland  
2 School District or Southern Oregon University. Student members under the age of 18 shall  
3 serve as non-voting, ex-officio members. Both voting and ex-officio members shall be  
4 appointed by the Mayor with confirmation by the City Council. The primary staff liaison  
5 shall be appointed by the City Administrator and shall serve as the secretary of the  
6 Commission.

7 2.27.020 Powers and Duties

8 A. Develop recommendations for the City of Ashland’s CEAP and any updates to  
9 the CEAP.

10 B. Recommend modifications to benchmarks, targets, or actions contained in the  
11 climate plan as needed to incorporate the best available science and practices to  
12 achieve the City of Ashland’s climate-related goals and targets.

13 C. Manage a process for considering amendments and updates to the CEAP.

14 D. Monitor and make recommendations on the implementation of the CEAP for the  
15 community and for City operations

16 E. Periodically review progress toward achievement of the CEAP’s Greenhouse  
17 Gases (GHG) and fossil fuels reduction targets.

18 F. Recommend changes in City ordinances, administrative rules, and processes that  
19 facilitate or incentivize residents and businesses to reduce GHG emissions.

20 G. Work to ensure that the CEAP incorporates long-term social, economic, and  
21 environmental goals.

22 H. Work to ensure that the CEAP is socially equitable for all community members  
23 including low-income, young people, persons of color, the elderly, and those living  
24 with disabilities.

25 **SECTION 2. Codification.** In preparing this ordinance for publication and distribution, the  
26 City Recorder shall not alter the sense, meaning, effect, or substance of the ordinance, but within  
27 such limitations, may:

- 28 (a) Renumber sections and parts of sections of the ordinance;  
29 (b) Rearrange sections;  
30 (c) Change reference numbers to agree with renumbered chapters, sections or other parts;  
(d) Delete references to repealed sections;
