## **Summary:**

Although the budget is adopted on a biennium basis, Oregon Budget Law requires an annual Property Tax Levy. The proposed Property Tax Levy Rate for Fiscal Year 2019 (July 1, 2018 to June 30, 2019) remains unchanged from last year and adjust the Bonded Debt to reflect actual costs.

# **Actions, Options, or Potential Motions:**

I move to approve "A Resolution Levying Taxes for the Period of July 1, 2018 to and Including June 30, 2019, Such Taxes in the Levy rate of \$4.2422/\$1000 Assessed Value Upon All Real and Personal Property Subject to Assessment and Levy Within the Corporate Limits of the City of Ashland, Jackson County, Oregon".

Staff recommends approval of the resolution setting the Property Tax Levy

#### **Background and Additional Information:**

The biennial budget for the City provides appropriations and expenditure authority for a two-year period. However, the Council must elect to levy taxes annually. The proposed Property Tax Levy for July 1, 2018 to June 30, 2019 remains unchanged from the previous year. The resolution can be adopted after holding a public hearing on the item. It is anticipated that the Property Tax Levy for Fiscal Year 2019 will generate the proper Bonded Debt amount along with \$10,821,200 consistent with the BN 2017/19 Budget.

# A RESOLUTION TO LEVY TAXES FOR THE FISCAL YEAR JULY 1, 2018 THROUGH JUNE 30, 2019.

## THE CITIZENS OF THE CITY OF ASHLAND RESOLVE AS FOLLOWS:

**Section 1**. That the City Council of the City of Ashland hereby levies a tax upon all real and personal property subject to assessment and levy within the corporate limits of the City of Ashland, Jackson County, Oregon for general government purposes.

**Section 2**. The City Council also levies a tax on all taxable property within the City of Ashland as authorized for the repayment of General Obligation Debt.

**Section 3**. That the City Council hereby declares taxes levied as follows:
