HOW TO MAKE A RECOMMENDATION

You have until **9/4/2019** to make your recommendation. Below are your options for renewals:

RECOMMEND APPROVAL

1. **DO NOTHING.** If you do not submit a recommendation by **9/4/2019**, the OLCC will process the renewal application as a favorable recommendation.

RECOMMEND DENIAL (see additional information on page 2)

1. File an unfavorable recommendation, stating the grounds for the unfavorable (must meet the denial criteria on back of form); **OR**
2. Make a written request for additional time to complete an investigation. The request must state: 1) you are considering making an unfavorable recommendation; 2) the specific grounds being considered. **The grounds must be one referenced in Oregon Administrative Rule 845-005-0308(3).** If your request is granted you will be given a 45-day extension to file your unfavorable recommendation. Unfavorable means recommending denial of a license or requesting restrictions be placed on a license.

REASONS WE MAY DENY OR RESTRICT A LICENSE
ORS 471.313(4)(5), OAR 845-005-0320, 845-005-0321, 845-005-0322
845-005-0325, 845-005-0326(4)(5) or 845-005-0355

The following is a list of problems relating to the **APPLICANT** or **BUSINESS** that OLCC can consider to refuse or restrict a license:

1. Applicant has a habit of using alcohol or drugs to excess
2. Applicant makes a false statement to OLCC (must be related to a refusal basis)
3. Applicant has been convicted of local, state or federal laws that are substantially related to the fitness of holding a liquor license
4. Applicant has demonstrated poor moral character
5. Applicant has a poor record of compliance when previously licensed by OLCC
6. Applicant is not the legitimate owner of the business
7. The business has a history of serious and persistent problems at this location. The problems can include:

- obtrusive or excessive noise, music or sound vibrations
- public drunkenness
- fights or altercations
- harassment
- unlawful drug sales
- alcohol or related litter

OLCC is not able to consider the following issues when deciding to renew a liquor license:

- lack of parking
- increase in traffic
- too many licenses in a specific area (saturation)
- entertainment type - nude dancing, gambling, live bands, etc.
- increased noise
- zoning issues

In order for an unfavorable recommendation from a local government to be valid, the grounds must be found in the license refusal bases of ORS 471.313(4), 471.313(5), OAR 845-005-0320, 845-005-0321, 845-005-0322, 845-005-0325 or 845-005-0326(4)(5) or the license restriction bases of OAR 845-005-0355, and must be supported by reliable factual information.

Pursuant to your request for information relevant to the renewal of liquor licenses, I am providing the following information. I have brought these establishments before the City Council in the past and this is an update on their dealings with the Ashland Police Department.

O'Ryan's Irish Pub (I-Pub)

The owner of O'Ryan's Irish Pub, Mike Szelong, continues to work with the police department to mitigate problem behavior at the I-Pub.

Over the last year the I-Pub generated 18 cases, as opposed to 23 the year before and 25 the previous year. There were seven calls of disorderly conduct (14 the year before). There were three assaults reported to have occurred inside bar over the last 12 months. This is up from none during the previous 12 months.

I am unaware of any infractions issued by the OLCC to the I-Pub over the last year.

Vinyl Club

The Vinyl Club (VC) is currently operating under restrictions imposed by the OLCC. These restrictions were applied after the Council recommended the license not be renewed one year ago, and after the APD provided information to the OLCC regarding the complaints generated at the VC. These restrictions include:

- The VC must have at least two licensed security guards on duty when open
- The security guards must wear identifying clothing
- The VC must maintain an incident log
- The VC must maintain a video surveillance system
- No new patrons may enter after 1:30 a.m.
- No straight shots may be served after 1:30 a.m.
- All alcohol sales must cease at 1:45 a.m.
- Patrons may not possess more than one drink
- a one-ounce jigger must be used when pouring alcohol for drinks

The Vinyl Club remains under the scrutiny of the OLCC for several violations. The VC is presently facing a fine of \$4,950 (which was due by the August 14, 2019) or a 30-day suspension if the fine is not paid.



In the past year there have been two complaints of unreasonable noise coming from the Vinyl Club. In the previous year there were 14.

There were 7 cases pulled from the Vinyl Club and surrounding area (but seemingly connected to the VC) in the last year, down from 17 during the preceding 12 months. There were no assaults reported at the VC.

Stop N Shop

While in years past the Stop N Shop at the corner of Lithia Way and Pioneer has been a focal point of negative behavior, this behavior seems to have abated somewhat. This store is the only place in the downtown area where community members can buy to-go alcohol in the traditional manner. For clarification, there are some other locations that sell growler-style to-go alcohol, but the Stop and Shop is the only location that allows traditional sales of alcohol to go.

Over the last 12 months there have been five open container citations issued in front of the Stop N Shop and five warrant arrests made. This is down from 13 and 10 for the preceding 12 months, respectively.
