**REASONS WE MAY DENY OR RESTRICT A LICENSE**  
**ORS 471.313(4)(5), OAR 845-005-0320, 845-005-0321, 845-005-0322**  
**845-005-0325, 845-005-0326(4)(5) or 845-005-0355**

The following is a list of problems relating to the **APPLICANT** or **BUSINESS** that OLCC can consider to refuse or restrict a license:

1. Applicant has a habit of using alcohol or drugs to excess
2. Applicant makes a false statement to OLCC (must be related to a refusal basis)
3. Applicant has been convicted of local, state or federal laws that are substantially related to the fitness of holding a liquor license
4. Applicant has demonstrated poor moral character
5. Applicant has a poor record of compliance when previously licensed by OLCC
6. Applicant is not the legitimate owner of the business
7. The business has a history of serious and persistent problems at this location. The problems can include:

- obtrusive or excessive noise, music or sound vibrations
- public drunkenness
- fight or altercations
- harassment
- unlawful drug sales
- alcohol or related litter

OLCC is not able to consider the following issues when deciding to renew a liquor license:

- lack of parking
- increase in traffic
- too many licenses in a specific area (saturation)
- entertainment type - nude dancing, gambling, live bands, etc.
- increased noise
- zoning issues

In order for an unfavorable recommendation from a local government to be valid, the grounds must be found in the license refusal bases of ORS 471.313(4), 471.313(5), OAR 845-005-0320, 845-005-0321, 845-005-0322, 845-005-0325 or 845-005-0326(4)(5) or the license restriction bases of OAR 845-005-0355, and must be supported by reliable factual information.

Pursuant to your request for information relevant to the renewal of liquor licenses, I am providing the following information.

## Oberon's Restaurant and Bar

During last year's liquor license renewal process Council asked that issues with Oberon's bar be part of this year's review.

In the last 12 months Oberon's only generated one case, which was for a warrant arrest. There was one disorderly person call at this location and six other calls for inconsequential matters.

I am unaware of any OLCC infractions issued over the last year.

## O'Ryan's Irish Pub (I-Pub)

The owner of O'Ryan's Irish Pub continues to work with the police department to mitigate problem behavior at the I-Pub.

Over the last year the I-Pub generated 12 cases, down from 18 cases the previous year. The cases generated were mostly for low-level issues such as warrants and disorderly conduct.

I am unaware of any infractions issued by the OLCC to the I-Pub over the last year.

## Vinyl Club

The Vinyl Club is closed, and I am unaware of any current attempts to re-open it.

## Stop N Shop

The Stop and Shop remains a source of negative behavior. The Stop and Shop is the only business downtown that sells certain products (high alcohol content "tall boy" drinks) that make up a significant majority of open container violations issued by APD. A map of all open container violations in the City

---



for January through August of 2019 and 2020 is attached. The map clearly shows a downtown-centered pattern. APD's downtown officers have attempted to work with the new owner of the Stop and Shop to mitigate some of the business' practices. The new owner does not appear inclined to participate in a meaningful way. In the last 12 months APD has responded to five incidents of disorderly conduct at the location. In addition to this, again, the open container issue seen most commonly in the downtown area appears to be centered around this location.

I am attaching a letter I wrote to the Chairman of the OLCC stating APD's intention to recommend that Council votes against endorsing the renewal of their liquor license. This letter was requested by the OLCC Inspector to summarize our involvement in issues surrounding the Stop and Shop.

I am also attaching a PDF map that shows open container violations issued from January through August of both 2019 and 2020, indicating Stop and Shop as being central to this activity.

Map of open container violations





As liquor licenses come up for annual renewal, the Ashland Police Department intends to request that the Ashland City Council recommend that the liquor license for Stop and Shop, 110 Lithia Way, Ashland, Oregon, be denied by the Oregon Liquor Control Commission.


The reason this request will be made stems from repeated liquor law violations that can be traced back to this business. The police department recently conducted an analysis of all open container violations in 2019 and 2020, each year from January through August, and mapped out each violation. It is clear that the violations are centered around the downtown area. There are two businesses in downtown Ashland, Stop and Shop and the Ashland Liquor Store. While some of the open container violations can be traced to the Ashland Liquor Store, the significant majority of them (high alcohol content "tall boy" cans) are attributable to Stop and Shop.

Attempts by our downtown patrol team to work with the staff of the Stop and Shop to mitigate these issues have not yielded positive results.

I am attaching a map with case numbers for open container violations, January through August for 2019 and 2020.

My request to Council to recommend non-renewal will be considered at a meeting in October. Thank you for the consideration.
