## Program Eligibility & Instructions

### Eligibility:

- ◆ Be a City of Ashland water utility customer.
- ◆ Install a **WaterSense labeled 1.28 gallon per flush** toilet in your home, rental or business.
- ◆ Be willing to have an inspection of the installation and a water use evaluation done on the house.

### Instructions:

- ◆ **Purchase a WaterSense labeled toilet.** Eligible models are identified with a WaterSense label. Verify by reviewing the list of qualifying toilets on the EPA website: <http://www.epa.gov/watersense>.
- ◆ **Inspection & Water Use Evaluation.** Once you have installed your new toilet you need to call the Conservation Division at 541-552-2062 for an inspection. At that time an appointment will be made to conduct both the inspection and the water use evaluation.
- ◆ **Application and Receipt.** When you call or come in to request your inspection you may fill out or pickup the toilet rebate application. You may then either mail-in the application with a **copy of the invoice** for the toilet, or have it ready for the inspector upon arrival for the inspection and water use evaluation.

### Rebate Amounts:

- ◆ For the replacement of an old toilet flushing 3.0 gallons or more; \$75 for the first toilet, \$60 for the second toilet and \$50 for the third toilet in the same residence or business.
- ◆ For the replacement of an old toilet flushing 1.6 gallons; \$35 for the first toilet, \$25 for the second toilet and \$15 for the third toilet in the same residence or business.
- ◆ In **new construction**, \$35 for the first toilet, \$25 for the second, and \$15 for the third in the same residence or business. A limit may be placed on number of rebates if budget constraints exist.
