### Fire scars, toxic soil and erosion

We welcomed winter weather this fall in southern Oregon. As the leaves blanket the ground in brightly colored mosaics, we all have hopeful thoughts of rain filling the lakes and reservoirs, snow adorning the mountains, and the dry soil softening for new spring growth. While the rain and snowpack are absolutely needed it will also pose new health concerns and hazards in a post-Almeda Fire environment.

The human caused Almeda Fire burned 3,200 acres, destroyed more than 2,600 structures, and displaced an estimated 5,000 residents in the worse fire in the history of southern Oregon driven by 40 mph winds and embers the size of tennis balls. The impact was devastating to life, property, and the environment. The acreage burned along roughly a 9-mile path including the riparian zone along Bear Creek home to native fish and other wildlife. Experts at the US Forest Service call it an urban conflagration, one that burned through dry grasslands, riparian areas with dense fuel loads from non-native blackberries, and of course, in urban areas with densely packed residences.

The weekends were speckled with rain and snow events during November and it has many worried. When water flows over burned structures and the contents that were once inside and now exposed, it can pick up anything that was



exposed in the fire, including lead paint, pesticides, plastics, rubber, solvents, and asbestos. During rain events, these harmful materials can get washed into local rivers and streams, which can be toxic to fish (and humans). Runoff from burned trees, shrubs and grasses can carry high levels of nutrients, which can lead to harmful algae blooms. Because the Almeda Fire burned with such high severity, the burned trees and shrubs lead to bare soil being left behind, which can become unstable during rainy weather causing severe erosion and increased sediments entering Bear Creek and other waterways. More sediment in our streams can harm fish, pollute drinking water sources, and can smother gravel in streambeds that salmon use for spawning. Additionally, less stable hillsides may increase the likelihood of dangerous mudslides.

Many government and private entities are working diligently to restore the banks of Bear Creek and preserve the natural space and wildlife who need it for survival. Contact Jackson County Parks to learn more about what you can do to support revitalization efforts and about the 20-mile Greenway Path which has been slowly reopening for public use.
