Pioneer II

The City of Ashland will offer our electric customers the opportunity to invest in a 63.5 kW community solar electric system to be installed on a City building. Many customers may want to use solar energy but do not have adequate access to solar resources on their own residence or business, or may not have the financial resources to install a solar electric system of their own. Others may simply prefer to invest in a community owned and operated solar electric system rather than install and maintain their own system.

Safety Tips for Crosswalks

- ❑ A stopped car may be a clue that a pedestrian is crossing. Don't pass. It is unsafe and illegal to pass any vehicle stopped at a crosswalk for a pedestrian.
- ❑ When stopped at an intersection, do not block the crosswalk. Always leave room for pedestrians to cross.
- ❑ Watch for pedestrians, especially children, when exiting driveways or when backing out of parking spaces in parking lots.
- ❑ Pedestrians move at different speeds. Be patient with children and older adults who may take extra time to cross the street. Around taverns and bars be alert for pedestrians who may have slowed reaction times due to impaired judgment.

Curbside Recycling

Ashland Sanitary & Recycling has an extended curbside-recycling program. Customers within the Urban Growth Boundary are provided with a 65-gallon roll cart that will hold most household recyclables.

The cart can be used for newspaper, corrugated cardboard, plastic bottles and tubs, aluminum cans and foil, phone books, magazines, catalogs, tin cans, metal lids and some mixed waste paper (see below). Use the small blue recycling bin for glass and motor oil.

Which mixed waste paper can I recycle?

Magazines, scrap paper, cereal and cracker boxes, frozen food boxes, labels from metal cans, office paper, opened mail, paper egg cartons, shredded paper (strips only), six-pack holders, shoe boxes, wrapping paper, phone books, paper bags, newsprint.

The system will consist of 363 solar electric panels rated at 175 DC Watts. Each panel will generate an estimated 230 kWh of electricity annually. Ashland customers can purchase the virtual output of panels for a minimum of 20 years for \$825 each, or as little as 1/4 of a panel for \$206.25. Each year the City will credit the electric bill of participants for the amount of electricity their panels have generated. The City will be responsible for the maintenance of the system.

Which mixed waste paper is not recyclable?

Candy wrappers, food contaminated paper (pizza boxes etc.), paper cups, paper plates, pet food bags, snack food bags, shredded paper (confetti style) stickers, tissue, waxed paper, milk carton and drink boxes.

What plastics can I recycle?

Any plastic bottle with a neck smaller than the base (milk jugs, pop bottles, juice containers, detergent bottles, water bottles, etc.) is acceptable. Please remove the lids and rinse the bottle. Margarine and yogurt tubs are also acceptable.

What plastics are not recyclable?

NO PLASTIC BAGS, plastic lids or any plastic bottle that contained motor oil, pesticides, herbicides or other hazardous materials.

Yard debris recycling is also available with our Green Debris Program for an extra charge.

How Fast is Ashland Growing?

Growth in Ashland has been expressed as one of the biggest challenges facing the community. The population in 2003 was 20,430 and as of July of 2007 it was 21,630 — a 5% increase or 1,200 more people in five years. The City's Comprehensive Plan projects that an average of 87 single-family homes and 71 apartment units will be constructed each year. These figures serve as benchmarks for planning purposes. The following chart gives a picture of growth in Ashland between 2003 - 2007.

Ashland Parks & Recreation Department, Rogue Valley Audubon Society, and the Klamath Bird Observatory will celebrate Migratory Bird Day on Saturday, May 10, from 8 am - noon at the North Mountain Park Nature Center. The event will offer a variety of engaging outdoor learning activities for birders of all ages, abilities and sleep habits! Hourly guided walks will visit the mist netting and bird banding station to view migratory and resident birds up close and learn more about local conservation. "Bird-friendly" shade-grown coffee will be served. Admire or sketch wild birds of prey from Wildlife Images. Plenty of fun activities will be offered for young bird enthusiasts.

This year's theme is "Tropics to Tundra." Migratory birds travel long distances between breeding and non-breeding sites throughout the Western Hemisphere. In 2008, Migratory Bird Day will explore the birds that make these fantastic journeys, the habitats on which they depend, and the people who are important to the conservation of birds and their habitats along the way.
