

Coronavirus (COVID-19) Business Economic Relief

With the extended closures being experienced by a significant number of our local businesses, schools and non-profit partners, the City recognizes the immense strain and challenges being faced, both emotionally and financially. While our collective priority is individual and community health and safety, a critical component in navigating this unprecedented impact on our economy is access to financial relief and support. Congress approved the CARES (Coronavirus Aid, Relief, and Economic Security) act several days ago setting in motion a series of programs with targeted and dedicated funding to support businesses large and small. Understanding programs, application process and the documentation required can be a significant challenge. The City continues to partner with the Chamber of Commerce as the primary information and support resource to assist local businesses.

Programs include:

- Paycheck Protection Program Loans
- Small Business Debt Relief Program
- Economic Injury Disaster Loans & Emergency Economic Injury Grants
- Small Business Tax Provisions/Credits

Stay Updated on Coronavirus (COVID-19)

To help ease concern over the Coronavirus (COVID -19) and spread correct information, the City has created a webpage ashland.or.us/coronavirus and will be updating a hotline (541) 552-2490 with the most up-to-date information from the Federal, State, County, and City governments.

The webpage includes information on:

Prevention and Health—links to the CDC, Oregon Health Authority, and Jackson County Health and Human Services as well as tips for staying healthy and what to do if you are sick.

City Government Updates—including current City closures and cancellation notices, how to interact with the City online or by phone, and direct support including adjustments to Utility Billing, Lodging and Food and Beverage Tax collections.

Current Restrictions—offering a timeline of the Governor's orders including mandated closures.

Local & Business Resources—where affected businesses can go for help, how to support local businesses, closures notices from OSF, Jackson County Library Services, Oregon DMV, and current operations of RVTD and Recology. This section also includes how you can help by donating items and time to organizations and by joining the adopt a neighbor program (adoptneighbor.org).

Annual Water Quality Report is Available

EPA'S notification requirements for the annual Consumer Confidence Report, better known as the Water Quality Report, allows the City of Ashland to distribute and provide access to the report via ashland.or.us/waterdept. A link will be found on the Public Works home page and the Water Department home page as well. Hard copies are available upon request and at public information racks located at; Ashland Public Library, SOU Library, Council Chambers, City Hall and the Public Works / Community Development building.



Dealing With Bears and Other Wildlife in Ashland

With spring upon us, the City of Ashland is seeing an increase in reported bear activity, especially in the areas above Siskiyou Boulevard and North Main Street. The City, and the APD would like to remind everyone to follow well-established protocols in dealing with all wildlife.

Residents should not leave food accessible to any wildlife and at no times should anyone deliberately feed wildlife. Residents who live above Siskiyou Boulevard and North Main Street are encouraged to contact Recology and get a bear-proof trash can. Allowing animals free or easy access to food encourages them to stay in town or close to town. This leads to them getting accustomed to being around people and houses, which increases the chance that they will have to be lethally removed. Residents are also encouraged to report wildlife encounters via the city's mapping tool, which can be found at ashland.or.us/wildlifemap. Residents can also use this tool to monitor where bear and cougar sightings have occurred to be better informed about taking walks or hikes in the area. Any emergency situations should still be reported directly to the police department by calling (541) 770-4784 or 911 as appropriate.

Lawn Replacement Program



If you've been considering replacing your lawn with waterwise landscaping, this may be perfect time to make that change. Lawn Replacement Rebates are still available for replacing thirsty green lawns that are currently watered using city water. There are many colorful waterwise, firewise and

pollinator plants to choose from. Add some character to your landscape this summer and save water while you're at it. For inspiration on how to create a landscape that is healthy, attractive and uses less water, visit the water wise landscaping website at www.ashlandsaveswater.org.

Most of our Lawn Replacement Program (LRP) participants do save water. In fact, we recently did a water savings analysis reviewing the last two years of LRP participants' water use. On average they are saving 20,000 gallons (approx. 2,700 cubic feet) of water per year, and many are saving even more. Wildfire Season is Still Coming

Ashland Fire & Rescue encourages proactive mitigation efforts on your property to help keep your home and the surrounding neighborhood safe from fire by meeting the June 15th deadline for Weed Abatement. Start preparing your home or business for wildfire season now, before the dry weather of summer becomes a threat and limits the ability to abate as safely as possible.

The use of gas-powered landscaping equipment like lawn mowers, weed eaters, trimmers, chain saws, etc. becomes restricted by mid-June due to increasing Fire Danger Levels. This severely limits the time available for you to meet the requirements of the City Ordinance for Weed Abatement, and in effect, delays the creation of effective defensible space against wildfire. Please, don't wait to abate.


Ashland Municipal Code section 9.04 requires weed abatement to be performed on all lots within city limits. Failure to abate and maintain weeds and grass by June 15th each year can result in fines for each day the violation exists, plus any abatement and staff costs.

Properties

Greater Than 1 Acre

Cut and maintain grass and weeds to no more than 4" in height:

- On abutting park rows, alleys and other right of ways
- Within 30 feet of every structure
- In a 15 foot wide buffer strip around your property
- In a 15 foot wide buffer next to access roads and driveways through

Be Ready to Evacuate or Shelter Indoors

Most years, May is the month we urge Ashland residents to prepare their home environments to either evacuate or shelter indoors, depending on the situation if a wildfire is approaching. Of course, this year many of us are already sheltering indoors due to Coronavirus. During this time, take stock of what [recommended "shelter indoors" supplies](#) you may lack in a wildfire context by visiting ashland.or.us/wildfireprep, as wildfire presents different challenges compared to the current COVID-19 crisis.

During a wildfire event, instead of sheltering indoors, you may be informed to evacuate. To receive important emergency notifications, including possible evacuation orders, sign up for Nixle, Ashland's community alert system, online or by text by visiting ashland.or.us/nixle. Once you've signed up, prepare yourself to evacuate by visiting ashland.or.us/evacuate and create an evacuation kit following our Evacuation checklist on ashland.or.us/wildfireprep.

Keep Cool and Save Energy

Summer weather is on the way and our hot Southern Oregon temperatures will be in full swing before we know it! During these tough economic and social times there are things you can easily do to help control your energy costs. Here are some tips to help you stay cool AND help to reduce your energy costs:

- Dress for the weather. Wear lightweight, loose fitting clothing on hot days.
- Drink plenty of cold liquids to stay hydrated.
- Turn off lights and fans in unoccupied rooms.
- Turn off or unplug unnecessary electronics.
- Use your kitchen and bathroom fans after cooking and bathing to remove hot steam from the air.
- Cook more meals in your microwave or InstaPot. It's quicker, more energy efficient, and heats the food instead of your house.
- Run your dishwasher at night, choose to air dry dishes rather than the heat option.
- Dry laundry on a clothesline.
- If possible wash clothes in cold water.
- Keep windows, doors, blinds and curtains closed during the day to keep cool air in. Open them when it cools down to let cool breezes through.
- Use portable or ceiling fans instead of A/C. Just increasing air movement can make you feel up to 5 degrees cooler, while using less energy. Since the fan won't cool the room, be sure to turn it off when you leave the room.
- Install roll-up bamboo blinds outside of windows that receive the most sunlight. Blocking the sun from the *outside* is more effective than blocking it from the *inside*.
- If using A/C set your thermostat to 78 degrees or higher.
- Use natural light if possible.
