SUMMARY

The Water and Wastewater Treatment Plants procure chemicals that are required to maintain consistent treatment plant operations and meet water quality standards as required by the Oregon Health Authority (water) and the Department of Environmental Quality (wastewater). Approval is being requested to award public contracts to the lowest bidders that meet the individual chemical specifications resulting from a formal competitive sealed bid (Invitation to Bid)

POLICIES, PLANS & GOALS SUPPORTED

Department Goals:

- Maintain existing infrastructure to meet regulatory requirements and minimize life-cycle costs.
- Deliver timely life cycle capital improvement projects.
- Maintain and improve infrastructure that enhances the economic vitality of the community.
- Evaluate all city infrastructure regarding planning management and financial resources.

BACKGROUND AND ADDITIONAL INFORMATION

The previous public contracts awarded for these chemicals were approved by the City Council on June 15, 2021, for a term that began July 1, 2021, and will end on June 30, 2023.

The contracts in need of approval now resulted from a formal competitive sealed bid (Invitation to Bid) and eight (8) bids were received in response to this ITB. This ITB allows for multiple contract awards and individual contracts will be awarded to the lowest responsible and responsive bidders for each of the chemicals. The term for these public contracts will begin on July 1, 2023, and end on June 30, 2024.

In accordance with AMC 2.50.080(C), the City Council acting as the Local Contract Review Board is required to approve the award of public contract(s) resulting from a formal competitive sealed bid.





In accordance with AMC 2.50.070(1), the multiple contracts resulting from a single ITB exceeds the delegated authority of \$100,000.00 for Goods and Services (type of procurement) and thus requires Council approval.

The City's intent is to award the public contracts for chemicals as follows:
