 - Ideas should be stated without elaborating and advocating for
 - Refrain from making comments on the ideas of others
- [Brainstorming activity](#) – Members were asked to share a word or phrase that comes to mind when considering the proposals

V. **FEASIBILITY and VALUES PRESENTATION. Criteria for decision-making**

- [Feasibility Criteria](#) – The criteria include:
 - Logistical (ease or difficulty of making changes), maintenance
 - Political (public and neighbor support / opposition), trade-offs
 - Regulatory
 - Environmental
 - Financial
- [Costs / Benefits to Community Criteria](#)
 - Safety
 - Neighborhood connectivity
 - Value to trail system
 - Economic value
- [Member proposal selections based on criteria, top three \(3\) for each member](#)
 - Following this exercise, Commissioner Eldridge shared the top three (3) aggregate proposals for the group. She noted that this does not mean that the remaining proposals are being abandoned, rather, it offers the group a starting point to start work on the most desired and feasible proposals. Members were encouraged to speak up at the meeting or email Landt and Eldridge to let them know which proposal they would like to be involved in.

Action Items:

Landt and Eldridge will form small working groups that are made up of subcommittee members with diverse viewpoints. The groups will meet on their own time, research feasibility issues and later report back to the subcommittee.
