SUMMARY

This resolution is to consider scheduled updates as well as new fees contained in the City's Miscellaneous Fees and Charges document. The majority of the Fees remain unchanged, with some new fees and others increasing by an inflationary adjustment.

POLICIES, PLANS & GOALS SUPPORTED

N/A

PREVIOUS COUNCIL ACTION

Adoption of the last Miscellaneous Fees & Charges was on June 21, 2022 with Resolution No. 2022-13.

BACKGROUND AND ADDITIONAL INFORMATION

The City charges for a variety of services provided to the public. The Miscellaneous Fees and Charges are updated and reviewed on an annual basis with the intent of providing an efficient way for Council to review and approve fees and charges as a whole. More complicated and specific rates, fees and charges such as Utility rates and Systems Development Charges are not included in the Miscellaneous Fees and Charges and are handled in separate Council actions. The adoption of the current fees and charges does not limit the Council's ability to create or adjust fees during the next year.

In addition to efficiency for Council in review and approval of fees and charges, the proposed attached fee booklet provides the public with one document that includes all miscellaneous fees and charges of the different Departments of the City. Attached is the draft booklet and draft resolution to establish or update the included fees effective July 1, 2023.

The fee booklet is presented in two versions - a redline version to view the changes and the updated, clean and unmarked version. In the redline version, all modifications or additions to the prior approved fees booklet are presented in red. If an entry is not reflected in red the existing amount or methodology used for calculation remains unchanged. Also attached are memos from departments explaining significant changes beyond inflationary adjustments.

FISCAL IMPACTS

Regular review and updating of fees and charges provides Departments with the ability to maintain the intended ratio of cost recovery for the services each Department provides to their customers and the public. This also ensures that the revenues projected in the biennial budget are achieved to appropriately offset the approved and appropriated expenditures of each Department.

STAFF RECOMMENDATION

Staff recommends approval of the updated Miscellaneous Fee and Charges.

RE: Miscellaneous Fees Update FY 2024

I am writing to inform you about the proposed increase in Miscellaneous Fees and Charges to account for changes in the Consumer Price Index (CPI). The purpose of these fees is to recover the costs associated with staff time dedicated to completing various tasks, such as planning application review, plan review, permit issuance, and public noticing. Community Development Fees were not increased in FY 2023 due to the City Council's directive. Consequently, the proposed fee increases incorporate both the FY23 CPI increase and the projected FY2024 increase to account for the mounting costs.

Over time, staffing costs and material costs have been steadily increasing. However, the failure to adjust the miscellaneous fees accordingly has resulted in a reduction of cost recapture. It is crucial to ensure that these fees keep pace with the rising expenses to maintain a sustainable cost recovery system. It is important to note that these fees are designed as charges for service, and they are borne by applicants seeking Planning Application approval for new developments. The fee structure is intended to ensure that developers seeking permits are wholly responsible for covering these costs, rather than having them absorbed by the general public.

The proposed increase of 13.5% takes into consideration the 8.5% increase that was not applied in FY23, per Council direction, as well as the 5% CPI increase for FY24.

Fees newly included in the attached Community Development Miscellaneous Fees and Charges table include:

- Food Trucks and Food Carts
 - Temporary Event Food Truck/Cart Permit. The City recently approved code amendments allowing food trucks to be temporarily located on private commercially zoned properties for special events. This new fee would is proposed at \$35.25 per special event.
 - Food Truck/Cart Permit: The permanent sitting of a Food Truck, Food Cart, or Food Truck Court/Pod (3 or less food trucks), to be operated continuously is to be processed as an Administrative Planning Action. This new one-time fee is proposed at \$420.50.
- Address Request
 - Previously, these fees were collected by the Engineering Division as part of their responsibility for address review and assignment. However, due to the relocation of the GIS Division from the Engineering/PW department, the Planning Division will be taking over this task. Community Development will now process the issuance of new addresses.

- Portable Sign Permit
 - o By explicitly including this fee in the approved Miscellaneous Fees table, it brings clarity to the sign permit process for applicants. Previously, there was no fee specifically designated for portable signs, which could have led to confusion. A "new sign permit" fee is as proposed is \$165.25 + \$3.00 per sq. ft. Although a new portable sign (sandwich boards) technically a "new" sign, the review for portable signs primarily focuses on factors like material, size, and location, with minimal need for site verification, therefore Community Development department considers a lower fee of \$35.25 to be appropriate for these cases.

Specific fees, including the *Preapplication Conference Fee, Tree Removal Permits Fee, Zoning Verification Letter*, and *Appeal Fee*, will remain unchanged without a CPI increase. These fees are intentionally kept low to encourage individuals and organizations to seek preliminary direction, address hazardous tree removal, research a property's zoning, and to appeal a planning action without facing financial barriers to gather information or exercise their rights. It is essential to maintain affordable access to these services and prevent escalating costs from negatively impacting decision-making in these areas.

Failure to adopt the proposed CPI adjustments while costs of services and materials rise would decrease cost recapture from applicants. This would result in a higher burden on taxpayers, as the General Fund would need to cover expenses associated with planning application reviews, plan reviews, permit issuance, and public noticing. Adjusting fees to reflect increased costs is crucial to ensure that the burden is appropriately borne by the benefiting applicants. Adopting the CPI adjustments is essential for a fair and sustainable system that adequately recaptures service costs, reducing the burden on the community.

SUBJECT: Miscellaneous Fees and Charges-Fee increases (Action)

Situation

All APRC fees for programs and services are itemized in the City's Miscellaneous Fees and Charges document. This item is on the City Council agenda for action at the June 6, 2023, business meeting. The City combines the fees and charges in one document so that citizens can easily determine the cost of services. On a yearly basis, the City Council reviews and takes action on the Miscellaneous Fees and Charges book.

Staff have prepared updates to some fees and charges to the Parks Commission for action and approval. Those fees include:

- Outdoor picnic sites in Lithia Park, North Mountain Park, and Garden Way Park,
- Special Event Application Fee
- Daniel Meyer Pool Fees
- Ashland Rotary Centennial Ice Rink Fees
- Hourly rental fees for exclusive use/commercial use of Pickleball and Tennis Courts

Background

APRC Staff are using the draft Financial Sustainability strategy to recommend fee changes and increases. The Financial Sustainability Strategy is a performance measure that allows staff to analyze the true costs (expenses), revenue, and participation of all the programs and services offered by APRC. The benefit of the financial sustainability strategy is that it allows APRC to make informed decisions that prioritize service delivery and fiscal responsibility.

Staff are committed to the Financial Sustainability Strategy and yet we also know that it is a long-term and complex process. There are also other criteria that go into the final recommendations for fee increases.

Those are:

- Inflation and fee increase history
- Program revenue (participation) and program expenses (costs)
- fee comparisons of other similar programs in the region.

Assessment

Inflation and fee increase history

- The last time fees were increased for the Ice Rink was in July 2019.
- The last time fees were increased for the Daniel Meyer Pool and outdoor facilities was in January 2015.
- The Consumer Price Index for the West Region (CPI-W) has had a cumulative increase of 20.6% since 2018. * See table to the right

•	For the fee proposals the increase in fees is less than 20% unless there is a cost adjustment
	for the fee to be more in line with regional comparisons.

March 2018: 3.2%

March 2019: 2.4%

March 2020: 2.5%

March 2021: 2.4%

March 2022: 8.7%

• Expenses are increasing every year and user fees have not increased yearly.

Program revenue (participation) and expenses of program (costs)

- The revenue is the total amount charged to the customer for an activity.
- Program expenses include both direct and indirect costs. A direct cost is something that can
 be traced directly back to the program. An indirect cost is a share of overhead
 apportioned to the service. It is incurred whether or not the service is provided
 (eg: building maintenance costs).
- If the program is not meeting the participation and expense targets, staff looks at other factors such as: a more tailored marketing approach, an increase in the fees to meet the cost recovery, or a potential divestment from the program.

Fee comparisons

 Comparing fees with other agencies around the region who charge for similar programs and services is another criterion used. Looking at other agencies such as Medford and Central Point Parks and Recreation gives an idea of what customers in our region are paying for similar services.

With the above criteria considered as well as the information presented on the financial sustainability strategy last week, staff are ready to move forward with a recommendation.

Recommendation

Staff are recommending the fee increases as attached to this memo.

Potential Motion

I move to approve the fee increases presented by staff and forward them onto City Council for the Miscellaneous Fees and Charges book.

Research Fee

- A. The City shall charge a research fee based on the hourly wage of the staff person doing the research, and the fee shall be billed in fifteen minute increments. The hourly wage used to calculate the research fee shall not include the cost of benefits. The City will establish a fee in its annual fee resolution that is reasonably calculated to reimburse the City for the actual cost of making public records available, including locating the requested records, reviewing the records to delete exempt material, supervising a person's inspection of original documents to protect the integrity of the records, summarizing, compiling, or tailoring a record, either in organization of media, to meet the person's request.
 - The City may charge for search time even if it fails to locate any records responsive to the requestor even if the records located are subsequently determined to be exempt from disclosure.
 - Copies of documents provided by a routine file search of 15-30 minutes or less will be charged at a copy rate established in the annual fee resolution.
- B. The City may include a fee established to reimburse for the costs of time spent by the city attorney in reviewing the public records, redacting materials from the public records into exempt and nonexempt records. The City fee may also include the cost of time spent by an attorney for the City in determining the application of the provisions of ORS 192.505.
- C. The minimum fee is \$25. Any research estimate above \$25 will be provided in writing to the requester in advance. The requester must confirm in writing that he/she wants the City to proceed with making records available before the work is done

D. Prepayment shall be required if the amount of the request is greater than \$25. If the actual charges are less than the prepayment, an overpayment shall be refunded.

Research Fee

A. The City shall charge a research fee based on the hourly wage of the staff person doing the research, and the fee shall be billed in fifteen minute increments. The hourly wage used to calculate the research fee shall not include the cost of benefits. The City will establish a fee in its annual fee resolution that is reasonably calculated to reimburse the City for the actual cost of making public records available, including locating the requested records, reviewing the records to delete exempt material, supervising a person's inspection of original documents to protect the integrity of the records, summarizing, compiling, or tailoring a record, either in organization of media, to meet the person's request.

The City may charge for search time even if it fails to locate any records responsive to the requestor even if the records located are subsequently determined to be exempt from disclosure.

Copies of documents provided by a routine file search of 15-30 minutes or less will be charged at a copy rate established in the annual fee resolution.

- B. The City may include a fee established to reimburse for the costs of time spent by the city attorney in reviewing the public records, redacting materials from the public records into exempt and nonexempt records. The City fee may also include the cost of time spent by an attorney for the City in determining the application of the provisions of ORS 192.505.
- C. The minimum fee is \$25. Any research estimate above \$25 will be provided in writing to the requester in advance. The requester must confirm in writing that he/she wants the City to proceed with making records available before the work is done

General. Fees shall be accessed in accordance with the provisions of this section.

Plan Review Fees. When a plan or other data are required to be submitted, a plan review fee shall be paid at the time of submitting plans and specifications for review. Said plan review fee shall be as set forth in Table A. Separate plan review fees shall apply to retaining walls or major drainage structures as required. For excavation and fill on the same site, the fee shall be based on the volume of excavation or fill, whichever is greater.

Grading Permit Fees. A fee for each grading permit shall be paid to the City of Ashland, Building Division as set forth in Table B. Separate permits and fees shall apply to retaining walls or major drainage structures as required. There shall be no separate charge for standard terrace drains and similar facilities.

TIE DOWN RENTAL POLICY

"All parties utilizing tied down parking are required to provide written consent to the Airport deeming the owner of any stored or parked aircraft as the last FAA registered owner of that aircraft. After an unpermitted failure to pay required rent or the aircraft becomes inoperable either mechanically or by regulation, and any such condition exceeds a ninety (90) day period for storage or parking, the Ashland Airport has the authority to treat the aircraft as a nuisance under AMC 9.12 Nuisance-Junk, and the Airport may thereby act according to AMC Chapter 2.31 Uniform Violation Abatement Process. Any appeal to the Ashland Airport taking such action is subject to AMC 2.30 Uniform Administrative Appeals Process."
