

What does “Affordable” and “Workforce” Housing mean?

“**Affordable Housing**” is a term that refers to a households’ ability to find housing within their financial means. Households that spend more than 30% of their income on housing and certain utilities are considered to experience *cost burden*.

“**Workforce Housing**” has come to mean housing targeted to households who may earn too much to qualify for affordable housing subsidies, but not enough to afford a market rate home or apartment.

The **Housing Department** at Access is a clearing house for a variety of housing related programs offered in Jackson and Josephine Counties.

The Housing Department provides several housing related services including: Housing Counseling services, “ABC’s of Homebuying” class, a state certified pre-purchase education course, First time homebuyer resources, one-on-one pre-purchase counseling, foreclosure prevention, predatory lending and fair housing complaints, rental counseling and reverse mortgage counseling. The SOHRC also administers down payment and closing cost assistance programs in Jackson & Josephine Counties.

Housing Discrimination?

Fair Housing Law makes it illegal to discriminate in residential housing on the basis of race, color, religion, national origin, gender, age, familial/marital status, disability, DV Victim status, and sexual orientation.

All households deserve fair and equal access to housing. If you have faced discrimination that limited your access to housing based on any of the listed ‘protected classes’ above contact the **Fair Housing Council of Oregon**.

Program staff receive and screen complaints of housing discrimination over a state-wide, toll-free hot line and whenever possible test allegations of fair housing violations.
