If the current irrigation system design is deficient or the new controller is not programmed correctly, installation of a smart irrigation controller may not result in reduced water use.

Program Eligibility & Conditions

Applicant Eligibility:

- ◆ Rebates are for City of Ashland residential customers who have a water account with the City. Commercial applications will be considered on a case by case basis.
- ◆ Applicant must schedule an irrigation evaluation to determine eligibility for rebate. If major improvement within the irrigation system or landscape is needed, those will need to be completed prior to rebate issuance. Approval is at the discretion of conservation staff.
- ◆ Rebate applies only to the installation of WaterSense® certified smart irrigation controllers. Eligible models are identified with a WaterSense label. Verify eligibility by reviewing the list of qualifying controllers and additional required equipment on the EPA website: www.epa.gov/watersense/product-search
- ◆ Additional equipment, such as a weather station, may be required for controller to qualify. Please visit the website listed above to confirm you have all of the mandatory equipment installed.
- ◆ Renters that assume the responsibility of paying the water bill are eligible for the rebate. The renter must obtain a permission form signed by the property owner in order to receive the rebate.

Terms & Conditions:

- ◆ New smart controller must be inspected by conservation staff before first half of rebate is issued. Controller must be properly programmed and functioning.
- ◆ After the new smart controller has operated for a full summer season, conservation staff will perform a follow-up visit to ensure the controller is still installed and functioning properly and to conduct a brief survey with applicant. After successful follow-up, the second half of the rebate is issued. *Smart Irrigation Controller must demonstrate a reduction in water use by 10% from the average of the highest three previous years to be eligible for the second half of the rebate.*
- ◆ Rebate will only be given for replacement of an existing standard irrigation controller or installation of a new smart irrigation controller where controller had not already existed. Product(s) must appear on purchase receipt dated on or after January 1, 2018.
- ◆ Submit the application to the City of Ashland Conservation Division, by mail, email or delivery to our office. You may also provide the application and receipt at the time of the irrigation evaluation and/or controller inspection.
- ◆ Rebates are offered on a first come first serve basis and are subject to available funds. Future funding will be dependent upon adopted conservation budget.
- ◆ Please allow 4 to 6 weeks for the processing of each rebate check.

Checklist:

- Schedule a free irrigation evaluation with City of Ashland
- Select, purchase and install WaterSense smart irrigation controller and any required equipment
- Complete the application and attach the receipt
- Schedule a smart controller inspection
- Receive first half of rebate
- Schedule a follow-up inspection after a full summer
- Receive second half of rebate

Rebate Amounts:

\$200 total WaterSense labeled smart irrigation controller with 12 stations or less.

\$250 total WaterSense labeled smart irrigation controller with more than 12 stations.

Note: Rebate cannot exceed the cost of the controller. A copy of your receipt for the purchase must accompany this application.
