Regarding the proposed protected bicycle lanes on N Mountain St and Ashland St, studies have continuously shown these types of improvements increase safety and usage of the cycling lanes. I have front and rear mounted cameras on my bicycle following an intentional and targeted assault against a cyclist, which was myself. These sort of protective features could have prevented such an assault. You can view my camera footage after every ride and see cars drift over the lines on the side of the road. This is so prevalent that car tires wear away the paint on the pavement in places around town, frequently near bends in the road. I have been riding for over 25 years and would like to ride for another 25 years.

Of related issues, simply keeping the pavement free from debris such as glass would increase safety. Even when there is a bike lane, you are forced to ride wide to the left nearest traffic just to avoid getting flat tires. If roads were maintained to the same standards as bike lanes I am certain that you would hear about that almost immediately. I myself have stood in the street near my house sweeping up glass which is very difficult because it likes to hide in all the crevices in the pavement.

That's why I am strongly in favor of providing physically protected bikes lanes wherever and whenever possible. Scott:

I am writing to support a proposal to enhance cycling safety in Ashland by converting painted bike lanes to protected bike lanes.

I do not live in Ashland, but I lead rides for the Siskiyou Velo Club throughout the Rogue Valley, including Ashland.

I have not read any recommended talking points, so my comments are from the heart and an untutored mind.

1. Why not make the proposed improvements?; the cost can't be that much greater and segregated lanes it will make it safer for cyclists (and motorists — see 3b below);
2. Ashland has the opportunity to host new SOU students every year -- make it safer for them on the road and facilitate their use of low cost transportation. Plus, when they go home or elsewhere, they can talk up the “progressive” city , where they received their education; this will support future tourism which is profitable for Ashland and further justifies any investments in better bike lanes;
3.
  - a), I wasn't a cyclist until I retired in the Rogue Valley. As a motorist, I was rarely irritated by serious cyclists with appropriate lights, safety conscious attire, who weren't weaving out in the road in front of me. But there are many people on bicycles who are not safety conscious cyclists; they don't use vehicle code-required lighting, they wear dark clothes even at dawn and dusk, and often veer into my lane unexpectedly, where it will be my fault if I hit them.
  - b), Protected bike lanes will make motorists more comfortable and less anxious, by creating a barrier for bicycles from the car lanes. The casual cyclist is much less likely to dart out from a segregated bike land; A car vs. cyclist encounter is an “accident” and ends badly for both;
4. East Medford attracts sports minded groups because of The Lithia Fields. West Medford will attract swimming groups from elsewhere, specifically to use the newly built swimming stadium.

Ashland could attract out of state cyclists who will want to register for events with lodging in downtown Ashland, “IF,” they can easily access the Rouge Valley greenway by exiting downtown via protected bike lanes. Plans are in place to continue the greenway to Grants Pass: Visualize Ashland <-> Grants Pass events.

I understand that if I want protected bike lanes in Ashland, I need to speak up now.

The re-paving projects under consideration on Ashland Street between Siskiyou and Faith; and North Mountain from East Main to I-5 are especially important for bicycle safety. These are areas that have heavy traffic and are also popular areas for bicycles.

I do want protected bike lanes in Ashland. When we have to ride alongside traffic, it is so stressful. In "Nextdoor", I have read several stories of people riding their bikes on Ashland Street who have had cars or trucks swipe by them dangerously close – whether on purpose or by accident. "The CDC reports that somewhere around a thousand bicyclists are killed every year in the U.S. Over 130,000 are injured in crashes." As an older person, I am a little less confident on a bike these days and really need the security of a separate lane. Also, it makes sense to provide a safe lane for our college students to get back and forth to the downtown.

Another reason that I encourage Ashland to have protected bike lanes is to encourage more healthy habits. I would ride to the Y – if it were just a little easier (It is easy from downtown, along the bike lane to the cemetery, then it becomes wonky). It is similar to the idea of having a 50-100 acre dog park, to encourage people to walk and ride bikes safely with their pets, rather than sitting while their dogs socialize. When we encourage healthy habits by designing with healthy habits in mind, people embrace the change. This is a concept for Blue Zone development. And "Blue Zone Communities have shown to benefit from better health, significant medical cost savings, productivity improvements, increased economic vitality and lowered obesity and smoking rates." (<https://www.bluezones.com/blue-zones-project-results/>). Why not plan for a healthier more vibrant community, as you are doing with the protected bike lanes?

There is something else I offer for consideration. Technology is coming out with affordable micro car ebikes such as the Elf (<https://organictransit.com/>) or Pebble (<https://www.better.bike/>) etc. I am interested in purchasing one as soon as they are really on the market. You don't have to register or license it as a regular car or buy insurance. Do you travel on a bike path or the street? I am a little confused on this point and hope that the Rogue Valley would make these rules clear for us, as we start to buy them. And, if we are to use bike lanes, will the lanes be wide enough to accommodate the bikes and the electric bike cars? How fast will we be able to go on them? I do not own one yet. I will own one by the time the street modifications are complete.

While we are considering street modifications, I also would like more streets that are off limits to cars, period. Isn't it nice to eat at an outdoor café with just people walking by? Do cars really have to go everywhere? In addition to pedestrian accident safety, right now we have to share the dirty air from cars, buses and trucks when we ride bikes, walk or eat outside. Hopefully, this is changing with e-cars, but the change is slow. Less car, bus, truck traffic in town is safer and healthier overall. Any chance you get to close a road to cars, buses & trucks will improve our town. Just one road will make a big improvement. The downtown square? Lithia Park? One cross road downtown? A gravel road behind Lithia Park?

*Imagine if roads were not simply repaired, but redesigned.*

Hello,

This is a comment in regard to the Transportation Advisory Committee's upcoming session on improving bike lanes in Ashland. I strongly support such improvements.

Ashland is an eminently bikeable town, but we don't see nearly as many cyclists as we should on the roads. While some of us are confident dealing with conditions as they are on major roads in town (although a few spots on Ashland St. bike lanes are hazardous), many people are rightfully hesitant about biking near traffic moving at up to 40 mph.

As Ashland St. and N. Mountain St. are now slated for repaving, this is an ideal time for the city to improve the condition of bike lanes on these streets. This is one way to show that Ashland is thinking ahead about reducing pollution and greenhouse gas emissions, and promoting the health of its residents. Once the cycling environment is safer, I'd expect the attraction of cycling to spread to those who haven't seriously considered it up until now.

I would add that merely installing bike lane infrastructure does not accomplish this goal; maintaining it, keeping it clear of debris, and enforcing pertinent traffic regulations are essential continuing elements of success, and need to be incorporated in planning.

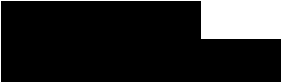

Good Morning Scott,

I'm emailing to say I would love to see more protected bike lanes, and I've heard that North Mountain and Ashland Street are up for paving projects in the near future. I 100% support and believe that adding new protected lanes is critical for the safety of all folks commuting in Ashland no matter their mode of transport, feet, two, three or four wheels.

In the 1.5years I've lived in Ashland I've seen many near misses across different streets, but having my business on Ashland St., means I have seen many more there. I've seen accidents happen because bicyclist who are afraid of using the road, ride illegally on the sidewalks and have run into or been hit by cars trying to pull out. They don't see them coming either because of shrubbery or because that's not where they're training their eyes to look.

I've seen a wipe out occur because a bicyclist went to the left to share the road after a bus stopped to get passengers and a car driving through either didn't see or didn't care and got dangerously close to the biker as they passed the bus and moved over into the right lane causing the bicyclist to ram into the curve and fall on the sidewalk. The driver never stopped. If bike lanes were physically separate with barriers, the bus would stop and the only cross traffic would be between the pedestrians getting on/off the bus and the bicyclist. The risk factor between a bicyclist and pedestrian is not none, but it is definitely not as severe as between cars and pedestrians/bicyclists.

We even recently had what seemed to be some sort of distracted driver situation, where the person actually ran their truck up over the sidewalk and crashed into parked cars in our parking lot in front of Pronto Print/Razi. Depending on the type of barrier used to separate bikes and regular traffic, this incident might have been prevented too.

As a previous non cyclist I understand the frustrations of the drivers in the cars too. I believe buffered bike lanes would do a lot to ease stress/tension for everyone in Ashland, and help us reduce the risk of life altering incidents.

I have learned that the city is considering options for new bike infrastructure on N. Mountain Ave. and also on Ashland Street. I write today to support the construction of protected (i.e. with substantive physical buffers) bike lanes on both. This would go a long way toward providing real transportation options for residents, most of whom currently opt **not** to ride bikes in the unsafe and incomplete network available to them today.

A slight reduction in the width of existing travel lanes will make room for a protected bike lane. These narrower travel lanes have the added benefit that they will slow car traffic (to better conform to posted speed limits) and improve safety for all road users, including those driving.

There's a robust body of research that shows that, if you build it, they will come. These sorts of street treatments will dramatically boost bike mode share. I hope you can make it happen.
